## SECTION 4. FIRST AID MEASURES

<b>General Information:</b>	Get medical advice/attention if you feel unwell. Show this safety data sheet to the doctor in advance.
<b>Ingestion:</b>	Call a physician or poison control center immediately. Do NOT induce vomiting without advice from poison control center. Never give liquid to an unconscious person. If vomiting occurs, keep head low so that stomach content does not get into lungs. If person is fully conscious, give 8 ounces (250 mL) of water. If medical advice is delayed and if an adult has swallowed several ounces (60 mL or more) of ethylene glycol, give 3–4 ounces (90–120 mL) of hard liquor such as 80-proof whiskey. For children, give proportionally less liquor at a dose of 0.3 ounces (1.5 teaspoons) for each 10 pounds of body weight, or 2 mL per kilogram of body weight.
<b>Inhalation:</b>	Move to fresh air. Treat symptomatically. Get medical attention if symptoms persist.
<b>Skin Contact:</b>	Wash skin thoroughly with soap and water. Get medical attention if irritation persists after washing.
<b>Eye Contact:</b>	Immediately flush with plenty of water for at least 15 minutes. If easy to do, remove contact lenses. Get medical attention if irritation persists.

### Most Important Symptoms/Effects, Acute and Delayed:

**Symptoms:** May irritate eyes. Harmful if swallowed.

### Indication of Immediate Medical Attention and Special Treatment Needed:

**Treatment and Notes to Physician:** If several ounces (more than 60 mL) of ethylene glycol has been ingested, early administration of ethanol may counteract the effects of ethylene glycol, such as metabolic acidosis and renal damage. Hemodialysis is the most effective means of removing ethylene glycol and its metabolites from the body. Consider hemodialysis or peritoneal dialysis and thiamine 100 mg plus pyridoxine 50 mg intravenously every 6 hours. If ethanol is used, a therapeutically effective blood concentration in the range of 100–150 mg/dl may be achieved by a rapid loading dose followed by a continuous intravenous infusion. Consult standard literature for details of treatment. 4-Methyl pyrazole (Antizol®) is an effective blocker of alcohol dehydrogenase and should be used in the treatment of ethylene glycol (EG) intoxication, if available. Fomepizole protocol (Brent, J. et al., New England Journal of Medicine, Feb. 8, 2001, 344:6, p. 424–9): loading dose 15 mg/kg intravenously, follow by bolus dose of 10 mg/kg every 12 hours; after 48 hours, increase bolus dose to 15 mg/kg every 12 hours. Continue fomepizole until serum EG is undetectable. The signs and symptoms of poisoning include anion gap metabolic acidosis, CNS depression, renal tubular injury, and possible late stage cranial nerve involvement. Respiratory symptoms, including pulmonary edema, may be delayed. Persons receiving significant exposure should be observed 24–48 hours for signs of respiratory distress. In severe poisoning, respiratory support with mechanical ventilation and positive end

expiratory pressure may be required. Maintain adequate ventilation and oxygenation of the patient. If lavage is performed, suggest endotracheal and/or esophageal control. Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach. If burn is present, treat as any thermal burn, after decontamination. Treatment of exposure should be directed at the control of symptoms and the clinical condition of the patient.

## SECTION 5. FIRE FIGHTING MEASURES

<b>General Fire Hazards:</b>	In case of fire and/or explosion, do not breathe fumes.

<b>Personal Precautions, Protective Equipment and Emergency Procedures:</b>	Isolate area. Use personal protective equipment, including anti-slip footwear. Keep unauthorized personnel away. Keep up-wind. Ventilate closed spaces before entering them.
<b>Methods and Material for Containment and Cleaning:</b>	Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.
<b>Notification Procedures:</b>	Prevent entry into waterways, sewers, basements or confined areas. Stop the flow of material, if this is without risk. Inform authorities if large amounts are involved.
<b>Environmental Precautions:</b>	Do not contaminate water sources. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, watercourses or onto the ground.

<b>Precautions for Safe Handling:</b>	Use personal protective equipment as required. Do not breathe mist or vapour. Avoid contact with eyes, skin and clothing. Do not taste or swallow. Wash hands thoroughly after handling. Do not handle until all safety precautions have been read and understood. Obtain special instructions before use.
